If we do not receive your reply, we will only send the printed Chinese version of future Corporate Communications to Hong Kong unitholders who are natural persons with a Chinese name using a Hong Kong address (based on the address appearing in the register of unitholders of Prosperity REIT maintained by the Unit Registrar), and the printed English version of Prosperity REIT's future Corporate Communications to all other unitholders.

If you elect the electronic means, a notification of the publication of Corporate Communication on Prosperity REIT's website in printed version will be issued to you.

Please note that you are entitled to change your choice as to the language and/or the means of receipt of Prosperity REIT's Corporate Communications at any time by notice in writing to the Unit Registrar or by email at prosperityenquiry@ara.com.hk.
